## INVESTMENT SIG

by Eric Holterman

At our December meeting Rick Parker of PBL demonstrated The Personal Investor. The current version of the program aids the investor in news and quotation retrieval from Dow Jones, portfolio updating and record keeping of past transactions for tax and profit/loss purposes and limited assistance in analysis. It can also serve as a terminal program for services other than Dow Jones and for purposes other than investing. It accommodates all existing features on Dow Jones and new ones as they become available. Multiple portfolios, stock split:s and partial sales of a given position are also handled. Holdings other than long positions in stocks and accumulation of dividend income are not part of the current version.

Rick indicated that an upgrade version is expected by the end of the second quarter which will include short positions, options, bonds, mutual funds and treasury bills. Files that can be accessed by VisiCalc will be used so that you can do whatever analysis you choose using VisiCalc.

We regret that we were unable to complete the hook-up with Dow Jones for part of his presentation. Hopefully we learn as we go and this won't happen again.

Since our January meeting date follows the newsletter deadine, a report on that meeting will be in the next issue.

Our February 17 meeting will be at 7:00 PM at the Minnesota School of Business, 11 So. 5th St. in downtown Minneapolis. Chrys Zaglifa will demonstrate the use of Visicalc and Visiplot/Trend in the analysis of security prices using different techniques such as oscillators, rate of change and moving averages. He will also show how to set up VisiCalc templates for analysis or other purposes. This is a "How to do it on your machine" meeting and will include comments on evaluating the results of your analysis.

Carefully check your March newsletter on the March meeting. It is tentatively planned to cover Compu Trac on March 17 at the Minnesota School of Business. Both location and subject may change.

## Business SIG <br> by Subir Chatterjee

The Business SIG met on Jan 13, 1983 when Kathleen Leo and Brent Lewis presented Quick \& Easy - a program generator that enables a non-programmmer to create complex record keeping databases with large numbers of records. The programs, once written, do not require the generator to run. Instead, a complete turnkey system is created. The programs have the ability to create menus and 'Help' screens, in order that an inexperienced operator could use the system. Kathleen and Brent came to Quick \& Easy via DB Master and dBase II - primarily because of speed, flexibility, and record size limitations. The programs run under $C P / M$. Our thanks to them for an excellent slide show (how about the Club buying a large screen monitor for the Business SIG?!) - it was quite the most professional presentation seen to date at the Business SIG.

The next month's program will be a topical subject - Taxes! The one thing we will, NOT be covering is 'tax advice'.- for that you will have to pay!! The program will review some different types of software, and so, if there is a package you are particularly impressed by, bring it along. Ron Androff will take us through HowardSoft's Tax Preparer to start out the meeting.

If there is any reader who is conversant with Business Graphics programs, I would be very interested in contacting you : I would like to include Business Graphics in a future SIG meeting. I can be reached on 330-7347.

## DOMs 18 thru 21 <br> (Disks of the Month) <br> by Alan Peterman

This month we are creating not one, but FOUR diskettes of material. The programs are not new, but they are ones that seem to be in high demand by members who have heard of them and want to try them out. The 4 disks include DIVERSI DOS to enhance your disk operations (and some other I/O operations), FIRE ORGAN for graphics, and two parts of the EAMON system for adventurers.

DIVERSI DOS (DOM\#18) is a modification of the Disk Operating System that has many features, which are fully covered in the extensive documentation that comes as part of the program disk. The heart (or at least the start) is a series of changes that speed up DOS operations including LOAD, WRITE and text file access. There are also some options to add a keyboard type-ahead buffer and even a print buffer using a RAM card. In addition there are options to load DOS into the RAM card and free up 10K more memory. As an editorial note, I am beginning to see more and more answers to the question of why one should have a RAM card and with the Revision E computer being 64 K it seems that this will become the "standard" configuration. There are several unique things about DIVERSI DOS including the fact that it is a commercial program that is distributed free and licensed by sending in the $\$ 25$ fee if you decide you like it and want to use it legally. The creator, Bill Basham, should be credited with an unusual marketing scheme. There are a few things that you lose with this system, the main ones being that the DOS error messages will print only a code number instead of the full message, and if you use the keyboard buffer some PEEKS that poll the keyboard will not work.

DOM \#19 is FIRE ORGAN, an exciting graphics/sound system that is written in a custom language called CEMAC. This disk is also a promotion (of a sort) by its creator, Brooke W. Boering. It will present you with a different graphic display for nearly any key you care to try pressing and most of these displays can be modified by the arrow keys or the game paddles (joystick). Most of these graphics should be viewed on a color screen for the full effect to be seen. Also on the disk are several binary files that are accessable with the BRUN commands to show you what the designers of the graphics had in mind when they wrote their 'scores'. After booting this disk, it is a good idea to hit the 'ESC' key to get the instructions.

DOM \#2O and DOM \#21 are part of the EAMON series. EAMON is an adventure game/system, written by Donald Brown, whereby one goes through adventures and builds up his fictional character. You MUST start with the Beginner's Cave (DOM\#20) to get a character before trying any of the more advanced caves. At present I believe that there are about 15 different adventures available in the public domain.

EAMON MAKER (DOM ${ }^{2} 21$ ) lets you create your own adventure. There are many possibilities of traps, mazes, room exits, and options available; you can create whatever you want. There is extensive documentation as part of the disk to tell you how to create these scenarios. I have been told that there is a contest from CALL A.P.P.L.E. for the best EAMON adventure and some sort of prizes. Also, at least one of our members has written a quite long and difficult EAMON adventure. If I get some requests for more of these EAMON adventures as DOMS, I will be glad to release as many as wanted!

## DAN ON PRINTERS

Selecting a Daisy Wheel Printer

If you read the minutes in December's newsletter, you might have noticed that the club board authorized me to go ahead and find a printer suitable for producing the newsletter. The criteria which I used to select a printer are not too different from what I believe should be used by anyone who would want a letter quality printer for a small business or industrial application. Broadly, the criteria are:

1. Excellent print quality. The quality must approach that of typesetting.
2. High reliability. Service costs are sufficiently high these days that a few service calls could cost more than the original price of the printer. One should expect the printer to run for a couple of years without being in a shop. That is, the Mean Time Between Failures (MTBF) should be greater than the number of hours used during those two years. Today the better printers are getting MTBFs of 2500 to 3000 hours. ( 30 hours/week for 2 years) To me such performance is very satisfactory.
3. Cost. Letter quality printers have followed the general trend in the micro-computer industry and have come down in price as a result of advances in electronics. One should expect to capitalize on this trend.
4. Features. For the newsletter I probably demand more bells and whistles than the average business user might need. For example, the following features are important to me:

- Proportional spacing. This means the ability of the printer to respond to proportional spacing commands from word processors that support that feature. Such word processors are: Executive Secretary, Format II, Screenhandler II, Wordstar and an upcoming enhancement to Pie Writer. Beware that some printers, such as the Olympia, may appear to have Proportional Spacing but the feature provided is internal to the printer, such that the spacing cannot be controlled by the word processor. This so-called proportional spacing is, in my opinion, a gimmick and
absolutely useless! article has been

Note that this incremental spacing. In this case the characters are at an even pitch, 12 per inch here, but the inter-word spacing has been adjusted so that it is the same for all words on a line.

- Bold and/or Shadow print. Bold Print allows the program to tell the printer to print 'bold' (i.e multi-strike the characters in the word) one or more words. Shadow print is similar to bold except that the print head moves $1 / 120^{\prime \prime}$ before restriking. Some word processors provide the capability to make multiple passes over a line, selectively restriking certain words. With such software you do not need the Bold or Shadow Print capability.
- Graphic mode. This allows you to plot lines or do graphic sorts of things similar to what can be done with most dot-matrix printers. Graphic mode usually comes in conjunction with bi-directional paper movement and programmable vertical paper motion. Besides the obvious use for graphing, the latter allows you to do superscripting and subscripting. The little map of Minnesota at the end of each story in this newsletter was prepared using Graphic mode.
- Programmable vertical paper motion. This allows you to print with line spacing other than the usual 4 or 6 lines to the inch. All of the printers evaluated which had this feature move the paper in $1 / 48$ th inch increments.
- Bi-directional printing. This allows you to print successive lines without returning the head all the way to the left margin. It effectively increases your print speed.

There are many other features offered on some of the printers. Their utility will depend a lot on how inquisitive you are. There is not room here to discuss every conceivable feature. All I can suggest is that you read the specifications carefully.

(1) You can software-select a horizontal spacing of $8 / 120$ ths of inch but I couldn't find a 15 pitch print wheel!
(2) The spec sheet says you can bold double print but there was nothing in the manual telling you how to do it. It might be a typewriter function which, like the proportional spacing, is useless to the serious word processor user.
(3) NEC models 3530 and 7730 have parallel interfaces.
(4) Manual is for operators only. An excellent product description or specification is available in which all programming details are well laid out. In the case of Apple, they claim to be working on a comprehensive manual.

Not included in the table above are several other daisy wheel printers. Among these are:

Olivetti DY211. This printer is similar to the Olympia and priced slightly less. The ads claim proportional spacing. I don't konw whether it can or not.

SCM TP-1 SCM is Smith Corona and this is the printer that has the distinction of being the lowest priced Daisy Wheel on the market. It often sells in the $\$ 600$ to $\$ 700$ range. It has limited features and is slow 12cps. One of our members, Arsen Darnay uses it extensively and likes it (I think).

The Apple LQP is in fact a brand new Qume, which is designated by Qume as a Qume Sprint $11 / 130$ - 130 character print wheel. Qume are marketing the new printer as a Qume Sprint 11. The Qume version retains the 96 character print wheel used on the Sprint 9 series. The older Qume Sprint 5s had some reliability problems, as did most of the daisy wheel printers of 2 and 3 years ago. One person reported some minor reliability problems with the 9/45. However, $I$ have heard negative things from at least one source on every printer evaluated. The Qumes produced very nice quality print.

The Apple LQP and Qume Sprint 11 differ from the older Qume Sprint $9 / 45$ mainly in the electronics. The Sprint $9 / 45$ has its electronics on 3 printed circuit boards. The 11 has been put on one board through use of large scale integrated circuit technology. The reliability should therefore be improved. The Apple LQP has slightly different firmware than the Qume Sprint ll.

All of the printer manufacturers provide an optional adjustable paper tractor mechanism priced between $\$ 200$ and $\$ 300$. Note, however, that some manufacturers supply both uni-directional and bi-directional tractors, the latter being more expensive. If you want to use a bi-directional print motion capability, you must purchase the bi-directional tractor. Some supply cut sheet feeders which can sometimes cost as much as the printer!

All of the printers provided excellent quality of print in the sample viewed or during demos except the C.Itoh which printed unevenly and was obviously mis-adjusted. We couldn't find anything in the manual telling one how to re-adjust, although I'm sure that there must be a way. The fact that it was apparently delivered that way bothered me somewhat.

NEC have the largest variety of printers. Both the $35 x x$ and $75 x x$ are new units with many program features. Like the Apple LQP, the electronics has been consolidated onto one board compared to earlier versions. The NEC 3515 and 7715 are Diablo 1610/1620 compatible printers. If you have software designed for the old Diablos, you can plug in the $x \times 15$ and expect it to work. The NEC 3510 and 7710 have serial interfaces. The 3530 and 7730 have parallel interfaces. Supposedly NEC are bringing out a brand new machine within the next few months, but $I$ don't know anything about it.

The NEC thimble has a tendency to show uneven print in the vertical direction. This weakness is hard to spot and may be of no consequence to most people.

## WHO IS NIFTY INFO?

While the Apple $][$ enjoys the widest selection of software available for any computer, there are many applications where the available software lacks affordability, friendliness, and speed. Nifty Info is a group of computer enthusiasts who have organized to develop and market software that fills this gap. Our first software package is a word processor. Although there are many word processors on the market, Word Machine will satisfy the needs of many users better then anything now available and at $\$ 39.95$ its affordable.

## WHATS A WORD PROCESSOR?

In general a word processor is a program designed to manipulate text. Functions common to most word processors allow the easy correction, insertion, deletion and rearrangement of text. Its widely recognized that word processors are among the most useful programs available for either home or business.

## "DO IT ALI" SYNDROME

Beyond the basic abilities common to the majority of word processors, most of the extra features offered by the "Do It All" programs are designed to support special hardware or to simplify the composition of highly formatted documents. However, in making complex operations simple, simple operations have become complex. All microcomputers have limitations and once the complexity of a program saturates its host computer, the addition of more features must. result in tradeoffs. Its evident by sluggish operation, multiple operating modes and cluttered displays that many of the word processors now on the market have gone beyond the saturation point and have sacrificed fundamental performance in favor of extra features. Some print wheels are easier to change than others. The Diablo 620 just drops into place. The NEC thimble is lifted out by placing two fingers inside the thimble and pulling straight up. One of the hardest to change in my opinion is the Diablo 630 which requires pulling the wheel forward by its hub in what amounts to a very tight space. Olympia, Brother, Comrex and Daisywriter are usually dispensed from little plastic cartridges. Incidentally the SCM printer has the lowest cost daisy wheels.

The Diablo 630, which in Diablo's own words is a 'mature design', seems to require a metal print wheel in order to make a decent looking image. The other printers all print nicely with their standard plastic wheel. Some say the metal print wheel is stronger, but it is also brittle and can fracture. At around $\$ 45$ apiece they are not cheap. I, personally, would rather replace plastic print wheels a couple of time a year and have one or two spares on hand.

The Brother, Comrex and Daisywriter all use the same print mechanism. The Brother, in particular, seems to have gotten a reputation for reliability although it's only been out on the market for about 6 months. The specifications for the Comrex are so similar to the Brother that I suspect it may be made by the same company, but I don't know that for a fact! The Daisywriter literature states that its print mechanism is made by Brother. The reliability of the Brother is probably due to its mechanical design simplicity. A linear stepping motor drives the head along a stainless steel track without belts or pulleys.

Except for the Daisywriter, all of the printers with proportional spacing provide head movement resolution of $1 / 120$ th of an inch. The Daisywriter moves in $1 / 60$ th inch steps. Unfortunately this is probably a design limitation caused by using the linear stepping motor. The result of this limitation is that character spacing in proportional mode will not be as smooth as on other printers. The shadow in shadow printing will be offset by $1 / 60$ th instead of $1 / 120$ inch. However, the printing accuracy is still equal if not better than on other daisywheel printers. The Daisywriter also has one other interesting feature emulation of the protocol of NEC, Diablo 630, Qume and other printers.

All of the printers provide bi-directional printing. All of the printers can write at least 132 characters on a line at 10 pitch, and correspondingly more at more characters to the inch. See table above.

All of the printers are available with serial interfaces. Many of the printers come with parallel interfaces as shown in the table. Generally, it is cheaper to provide a parallel interface card and you can be assured that the printer will operate at maximum speed. Also one doesn't have to worry about strapping a serial interface card. This isn't hard but can be frustrating.

All of the printers offer some sort of character buffer. A buffer prevents the computer from waiting for the printer to do a RETURN, or the printer waiting for the computer to send more information when the cumulative print speed is faster than the average rate at which the computer outputs information. I wasn't able to obtain buffer information on all of the printers. The Diablo 620 comes with 1536 bytes standard; the Diablo 630 with 768 standard, 2688 optional. NECs, except NEC 7730, have 256 char buffers. The 7730 is selectable up to 163 characters. A 16 k buffer option is available on some NECs. The Daisywriter has 16 k standard and 48 k optional. A 15 cpi pitch was a requirement for our application although some might not use it. In many cases the 15 pitch wheels are only sold by the manufacturer and are not available through DP supply houses. I did see, or locate in a catalog, 15 pitch wheels for the NEC, Olympia and Apple LQP.

The availability of service is of paramount importance. Daisy wheel printers are electro-mechanical devices. In the introduction to this article $I$ stated that a MTBF of two years was very acceptable. That year will pass, and the printer will eventually break down. Some places where you can expect reasonable quality service are:

Apple Apple and Qume dealers.
Brother PBS, Digital Den, Team and other dealers sell one or other of these. Several dealers sell both of these printers.
Comrex Same as Brother.

Diablo Xerox stores. Xerox own Diablo! Computerland, PBS, Digital Den and others sell Diablo, too.
NEC Computer Professionals sell NEC and can get them fixed. Team and PBS also sell the NEC.
Olympia
Qume PBS/Hagen There's at least one Qume repair place in town. PBS, Digital Den and City Desk sell Qumes but are not authorized repair depots for Oumes.
Smith Corona Most of the dealers carry this printer. You probably can get it serviced by SCM typewriter agents.
I am sure there are other places which can repair the devices but $I$ wanted to feel secure in this requirement.

Some of the printers evaluated are not of the real heavy duty type (MTBF > 2500 hours). The less than heavy duty units include the Diablo 1620, the Olympia and Olivetti. This doesn't mean that they should not be considered. If you only plan to print 1 hour per day, then you don't need a heavy duty unit.

Warranties vary between 90 days and 1 year. Check this out before buying.

## WHICH ONE?

Only the Apple LQP, NEC, Qume and C.Itoh met my requirements for versatility, heavy duty printing and word processing features.

I selected the Apple LQP.
The Apple LQP has a 130 character print wheel. Unfortunately, the standard print wheel that comes with the Apple machine is filled up with Swedish, German and other European special accented letters. This
is unfortunate, because most people could theoretically order a custom wheel with 2 or 3 special symbols should they require such a thing. The nice thing about 130 characters is that you could squeeze 2 complete character sets on to one wheel. I am keeping my fingers crossed that Apple/Qume will provide such a wheel! There are currently 6 wheels listed for the Apple LQP including the standard 12 pitch, a 10 pitch, a 15 pitch and a bold.

If you don't care about the 130 characters and the Apple label, consider the new Qume Sprint 11 with 96 character print wheels. At a list of $\$ 1776$ versus $\$ 2195$ for the Apple LQP, you can probably buy it for less!

The NEC with 128 characters is, of course, similar in print font capability. NEC does have the advantage of having 125 different thimbles on the market. However, many of those are minor variations of a similar font to achieve the same sort of character set as provided by the Basic Apple LQP wheel. NEC also has print thimbles in Arabic, Kana, Russian and other foreign alphabets. There are also several thimbles on which there is a complete upper and lower case font and a different upper case font.

The Apple LQP, the C.Itoh and the NEC offer more program features than the others.

Service for the Apple LQP should be available from Apple and Qume Dealers. Service for the Qume is only available from Qume dealers, We print the equivalent of $500-1000$ pages a month or 20 to 40 hours of printing per month. This puts us in the heavy duty user category.

For our newsletter application the Apple LQP gets highest marks, with the NEC 3530 a close 2nd.

However, if you don't need all the jazz, than consider the Brother, Comrex or Daisywriter 2000. The Daisywriter offers more features at a slightly higher cost. All of these machines are low in cost and print really nicely.

## Part 1: An Overview

Before describing The Data Reporter by Synergistic Software, let me give you some background about myself and my experience with Micro-computer Data Base Management Systems (DBMS), so that the reader may be able to evaluate the source of these ideas. I am not a computer expert. Before I purchased my Apple II+ two years ago, I had never touched a computer. But I do love the Data Reporter and have found some things about it that the FIRST-TIME user without computer knowledge may find helpful. I have on my shelf four data base programs:

## 1. The Informer by Apple Orchard

This program is apparently no longer available and the company seems to be out of business. I purchased it when I purchased my computer, on the advice of the dealer. It is (was) a good DBMS for a beginner, but the search is very slow unless you know the record \# of the record for which you are searching. Also, the edit mode is somewhat cumbersome. I still have some of my data bases on The Informer and use it on occasion.

## 2. The Data Factory by Micro Lab

This is a very good DBMS. The best feature over the others with which I am familiar is its ability to manipulate numerical data between fields and then store the results in as many fields as desired. I use Data Factory for those data bases that require a lot of such arithmetic operations. I have both Version 4.0 and Version 5.0 , but $I$ have used version 5.0 only as a learning experience. It seems overly complicated and more sophisticated than I need and is rather intimidating at times. Its newest features do not seem that useful to me.

## 3. DB Master by Stoneware

I bought DB Master some time ago when I was planning a data base for the saving of computer magazine articles. I realized it would be the largest data base $I$ had worked with up to that time. Most of the dealers with whom I spoke regarding the
best program for handling large data bases indicated the only one to use was DB Master. I am aware DB Master is the largest selling DBMS for the Apple, but for me, it has many drawbacks. First, it takes a VERY long time to set up a data base properly. Next, after a data base is set up, the program is insufferably slow in moving from module to module. Also, DB Master has no provision for saving a sorted file or the results of a search to another new data base file. I do not have either of the DB Master utility packs, and it may be that some of these problems have been overcome, but as of now, all the files I had on DB Master have been moved to Data Reporter, and I no longer use DB Master.
4. The Data Reporter by Synergistic Sof tware

This is by far the best DBMS I own. All of the bugs of the earlier versions seem to have been removed. Synergistic is very helpful and concerned about the users of the program. Periodically they publish a newsletter free to users which is full of tips and enhancements. For me, the greatest feature of Data Reporter is that each file is memory-resident, and so searches and sorts are done without disk access and are unbelievably fast. After a sort is done, the sorted file may be saved to the same data disk or to another data disk without losing the original file. A file may be searched for all records that meet certain criteria and all records found may be saved to their own new file if desired. This allows almost unlimited access to and manipulation of records. In addition, files may be reformatted at any time so that a new file can be started using only some of the fields of the old file or adding new fields to the new file. The ONLY real drawback to the program that I can find is the inability to take numerical data from one field, operate on it by numerical data from another field and store the results in still another field. Data Reporter can do this only once, rather than unlimited manipulations, as does Data Factory.
The apparent limitation of file size to computer memory is not a real concern. The program has the ability to search through multiple files on one or more disks and thus is able to treat multiple files as one file, saving the results of a

# ASSEMBLY LANGUAGE REFERENCES

If you are interested in learning or learning about Apple Assembly Language, there are an increasing number of books available. Many of these are designed to help you learn on your own. I have found the following books in B. Dalton and several of the computer stores. I have not used all of them and do not have the assembly language capability to rate them adequately, though I do have a few comments. I suggest looking at the first five and selecting the one that meets your needs. The remainder of the list consists of books that relate to 6502 assembly language and not specifically to the Apple, though some of them have programs that have been verified on the Apple II.

Marvin L. DeJong
Howard Sams \& Co., 1982. \$15.95
Uses the Apple 6502 Assembler. Appears to be well-written with clear explanations. Shows how to interface with outside devices. This is my first choice.

Roger Wagner
Softalk Publishing, 1982. \$19.95
Uses the Merlin Assembler (similar to A.P.P.L.E.'s "Big Mac", but with enhancements -- same author). This is an expanded version of the first 12 or 13 sections of Roger's column in SOFTALK and has many good examples. It is well-written.

# PROTECTION of COMPUTER SOFTWARE

## PART 1 of 3 Parts

One of the most important challenges confronting the computer industry is how to define and protect ownership interests in software.

Recent legislation 18 U.S.C. \#2319, enacted May 1982, and Minnesota Statute 609.87-.89, approved March 1982, impose harsher criminal penalties for the piracy and counterfeiting of computer software and data bases.

Under federal jurisdiction the maximum penalty would be five years and/or $\$ 250,000$, limited by the exclusions of 17 U.S.C. \#117 -- ("It is not an infringement for the owner of a computer program to make another copy or adaptation of it if such copy or adaptation is an essential step in the utilization of the computer program in conjunction with a machine and is used in no other manner or if it is for archival purposes only.")

The Minnesota statute sets lesser sentencing guidelines but sets legal definitions for computer software, programs, systems, networks, access and property.

The protection of a software developer's investment can be accomplished by three traditional types of "intellectual property" laws: PATENT, COPYRIGHT and TRADE SECRET.

This month, we will talk about PATENTS. COPYRIGHTs and TRADE SECRETs will be covered in a future issue (probably next month).

## PATENTS

Of these three principal means of protecting proprietary interests in software, a patent provides the most comprehensive protection - if granted.

But in practice, according to the National Commission on New Technological Uses of Copyrighted Works-Final Report 29,94(1979), patent protection has been the least accessible. Despite strong interest on the part of the software manufacturers and strenuous industry efforts, few patents have been issued.

The process of obtaining a patent is tedious and expensive. And post-approval litigation is a certainty when a computer program is involyed.

Another problem is that patent protection and secrecy are incompatible. Once a patent application has been granted, the program is available for public inspection, and the theoretical monopoly of the patent holder may have no value.

Even more problematic than these practical barriers are the institutional and legal obstacles. There is the concern about whether the patent system could process the volume of applications that could potentially be generated by the industry (estimated as high as 10,000 new programs a day - 18 Jurimetrics J. $355, \mathrm{n}, 10$ ).

The legal questions bearing on the patentability of software are even thornier. The principal question is whether programs are "new and useful processes" and thus constitute patentable material, subject matter under \#101 of the Patent Act.

In GOTTSCHALK v. BENSON 409 U.S.63(1972), the first Supreme Court decision to deal with the patentability of computer software, the Court held that a programming algorithm for converting binary coded decimal numbers into ordinary binary numbers was not patentable subject matter. The Court was unwilling to grant a patent which would effectively preempt the use of a mathematical algorithm.

The next software patentability case to be decided by the Court, PARKER v. FLOOK 437 U.S.584(1978), involved a method for updating alarm limits during catalytic conversion processes.
The Court again disallowed the patent claims, reasoning that the only novel step in Flook's method was the use of a mathematical algorithm useful in producing automatic computerized adjustments in alarm settings. Since the application for use of the algorithm was not independently novel, it did not provide a sufficiently independent basis for patentability and thus did not take the algorithm out of the Benson ruling.

## TAX PROGRAMS

## by Dan Buchler

Several Mini'app'les members, including myself, have used HowardSoft'm Tax Preparer to prepare our tax returns. I bought Tax Preparer mail order, before it was available locally, for $\$ 60$. The list price was then $\$ 100$. HowardSoft ${ }^{\text {m }}$ mails out cards to all registered owners and for the first year, tax returns for 1981, they charged $\$ 35$ for the update. This year they wanted $\$ 50$ for the update and the list price has gone to $\$ 225$. I balked and so have some others. Somehow I think HowardSoft ${ }^{\text {m }}$ have lost sight of who their customers are!

Tax Preparer covered (for tax year 1981) Form 1040; Schedules: A, B, C, D, E, F, G, R\&RP, SE; Forms: 2106, 2110, 2210, 3464, $4562,4625,4726,4797,5695,6251$. That takes care of most things. You can create an attachment to any form for any line item. That is Tax Preparer's real forte in my opinion. The normal procedure is to select a secondary form, and to make a pass through it during which the program proceeds from line item to line item asking for a value or whether you want to create a supporting document. Where other forms are cross referenced and have been previously created, the program will pickup the corresponding values. You must make a pass though 1040 at the end to carry all the figures to their final destination (the 1040 itself).

When you are all done with entry, you proceed to the print phase. The IRS requires that Form 1040 submissions be on actual 1040 forms. All other forms may be 'emulated' on plain paper. HowardSoft ${ }^{\text {m }}$, like most of the tax program houses, provides a Form 1040 fill in program. You can buy 1040s with tear off pin feed edges, or you can tape a form to blank paper.

The program, written in BASIC, works OK but is incredibly slow. If you have only one drive, theoretically you can survive the print phase. In practice, it would drive you to the Hennepin Detox center! I used Tax Preparer succesfully last year.

One of our members ended up doing his taxes manually! Several of us had trouble carrying information forward from the 1980 tax year files to the 1981 tax year files. HowardSoft ${ }^{\text {m }}$ provides a utility for that purpose, but it didn't work very well. I have 4 major complaints about Tax Preparer

## 1. The price.

2. Speed of execution.
3. Flexibility. Though the ability to create individual supporting statements is a great feature, I sometimes want to deviate from the normal method of tax preparation. Tax Preparer is simply too complicated a program to try and modify.
4. No Minnesota capability.

I have therefore switched to another approach for 1982 tax returns. There are at least two companies which sell complete Visicalc ${ }^{m}$ models for tax preparation. PanSophics is one. The other,

offers Taxman-83 which covers form 1040; Schedules: A, B, C, D, E, F, G, RP, ES, U, W; Forms: 1116, 2106, 2119, 2210, 2440, 2441, 3468, 3903, 4136, 4137, 4255, 4562, 4625, 4684, 4797, 4798, 4835, 4874, 4952, 4970, 4972, 5329, 5405, 5544, 5695, 5884, 6249, 6251, 6252, 6478, 6765.

The price is $\$ 95$. Their update policy is undefined as of now. I reviewed their brochure and on the strength of that ordered a copy, which will supposedly be shipped on Feb lst. I am gambling on being able to convert the Visicalc ${ }^{m}$ models to THE Spreadsheet. Transfer of data from form to form is accomplished using DIF files. THE Spreadsheet text files should be equivalent.

Now Atsuko doesn't support Minnesota, but, I think it should be relatively easy to modify for the state. After all, if you have Visicalc ${ }^{m}$ or THE Spreadsheet, you undoubtably have learned the elementary uses of same. Using a spreadsheet for table lookup is explained below in Arsen Darnay's article.

I'll let you know more when I have had a chance to play with the Atsuko version. Meanwhile, if you don't have lots of different form types, you might try Arsen's approach following.....

# IRS on SPREADSHEET 

by Arsen Darnay
The taxman cometh . . .
And users of Visicalc ${ }^{\mathrm{m}}$ or THE Spreadsheet can now prepare for April by putting the federal and state returns on the computer and turn the chore of tax preparation into play.

You don't have to be particularly skillful. The math involved is simplicity itself. The only tricky parts of the job relate to LOOKUP tables and using the Boolean functions in those few places where contingent calculations are necessary.

I've got my taxes on a single page of THE Spreadsheet -- federal and the state returns with all supporting schedules. I run a small business and have the schedules you need for reporting that sort of income as well, complete with itemized business costs and depreciation calculations.

I got myself thoroughly confused at the beginning until I laid out the scheme on paper first, a course I strongly recommend. With only 40 columns showing, the Apple's screen is not the ideal surface for providing you with an overview, and it helps to have the plan in front of you. (I have my monitor off to the side and use the Apple's surface as a table; until I hit on that approach, life was a lot harder.)

I've placed the LOOKUP tables on the extreme left of the spreadsheet. If your wife/husband works, and your separate incomes fall into different brackets, you'll need three LOOKUP tables -- federal for both (joint filing) and two for the Minnesota state return. In Minnesota each earner pays at his or her separate rate even on a joint return.

The LOOKUP took some experimenting because the instructions are not exactly selfevident. Let's say that you want to set up a LOOKUP table for the following range of earnings:

All right. Let's assume that the LOOK- UP table will begin at Al and that your taxable income is stored in Cell B5. Here is what you would enter:

The actual LOOKUP command would be given in Cell B6, let's say, the cell in which you want the tax to show up. The command in $\mathrm{B6}$ would be as follows:
B6 - LOOKUP(B5,A1.A3, A4.A6)

B5, here, of course, is the taxable income. A1 through A3 is the source range; A4 through A6 the destination range.

Here is what happens: THE Spreadsheet takes your taxable income (as stored in B5) and compares the value in B5 to those stored in Cells Al through A3. It selects the cell which is closest to but no more than the value in B 5 .

In the example above, a taxable income of $\$ 19,000$ in Cell B5 will result in an ERROR message because it is less than the lowest value in the range. Any value between 20201 and 24600 will return the result of the formula stored in its corresponding destination range, in our example the formula stored in A4.

The procedure works pretty much the same way in Visicalc". In both THE Spreadsheet and in Visicalc", you can use Boolean formulas to determine whether you owe them money or will get a refund.

Let's say that your tax obligation is $\$ 3890$ and that value is stored in Cell B6. And let's further suppose that your

withholding and estimated tax payments are summed in Cell B7. To find out what you owe or what you will get back, you can do as follows:

Let's say that your payments to the government were $\$ 4200$. In that case the first part of the formula will be " $\$ 3890$ is greater than $\$ 4200^{\prime \prime}$-- which is untrue and hence will return a 0 . Zero times any number is zero, therefore you don't owe them anything, and Cell B8 will say 0.

On the other hand, in Cell B9 the front portion of the formula will say " $\$ 3890$ is less than $\$ 4200$, " which is true and will return a l. The second part of the formula will then take 3890 away from 4200, leaving 310. This times 1 is 310. And that's your refund.

In my model I use the actual line numbers and a one word designation as labels on the spreadsheet itself so that I can walk from the real world to the computer world and back again without getting lost.

All the schedules, of course, can be linked to one another. And if the tax laws change -- as they always do -editing is easy enough. You change a few formulae and are ready to run again when . . . the tax man comes!

sort or search to new files if the user desires. One important note of caution: It is ALWAYS important to make back-up copies of your data disks BEFORE you start to do any data manipulations. This is especially true when doing a sort or search on multiple files, since this is one time the program will over-write the old file with a new one without first asking the user for permission. However, if you have a back-up copy, then you will have both old and new files on separate disks.
The Data Reporter disk also has two secondary modules (Report Generator and Analyzer/Plotter) that are very useful. However, it is important to realize that until you need these modules, the disk is rarely accessed due to the memory-resident nature of the program. This means there is very little disk-swapping, even with a one-disk system.

# MICROCOMPUTERS IN EDUCATION 

An Overview<br>by Jane Chatterjee<br>Conroy Associates

This is a short article on educational software, available for microcomputers. Later articles in the series will discuss some of the following areas in detail. As with other applications, the development of educational software has lagged the hardware availability. The first software available was mostly to teach computer programming, then more mathematical applications followed. First, we should distinguish such terms as Computer Based (or Managed) Instruction (CMI) from Computer Aided Instruction (CAI). The first terms refer to courses taught entirely or mainly on computer, with student testing and grading incorporated. CAI implies that the computer is one of the instructional media incorporated into the total course.

What types of software are available? The simplest type is drill and practice, where the student is repeatedly tested on a basic skill, for example, the use of mathematical operations. Tutorial-style programs teach concepts using an interactive tutorial approach, incorporating sophisticated branching to provide help on an individualized basis. Simulations are perhaps the most interesting type of program, educationally. They involve continuous student interaction, and can teach problem-solving skills.

The learning games, more of which are becoming available, provide some of the better quality educational software on the market. Computers may be used in the experimental setting in school, for data analysis, or linked into an experiment, to give a direct readout.

Computer software is available for all ages. There is a small, but increasing, amount of preschool software. At the elementary level, most of the software is in the basic skills areas of math, English and reading; however, other types are available. At the higher levels: junior
high, senior high and junior college, the software is naturally subject specific, and has usually been developed by individual teachers, on topics of their own interest. We should distinguish between educational software for home use and for school use. Software for home use needs to be reusable, to justify the initial cost, and a game approach is one way of ensuring this.

Educational software is usually developed by individual educators, and published by anyone, from the developer up to the nationally known text book publishers. There are now a number of specifically educational software vendors, such as Banana Software, owned by Marcia Braverman, who was instrumental in starting the Mini'app'les Educational SIG. Unfortunately for Mini'app'les, Marcia moved to Ohio.

The best educational software is developed as a result of cooperation between educators and programmers. Extensive use of graphics is important from the interest point of view, and quite sophisticated programming techniques are required. The educator is vitally important, to ensure that educationally valid instructional techniques are used. Software should be evaluated in the educational setting, prior to sale.

One of the serious pitfalls of producing educational software is to produce too simplistic materials, which are uninteresting and have little student interaction. Both dull drills and 'text books on disc' come in this category. The production of time-consuming, educationally-valid software is complicated by the difficulties surrounding copyright, and many game publishers are unwilling to enter the educational market. Among the benefits of using effective educational software are the novelty value to students and, more important, the degree of individualization possible, tailoring instruction to student need.

## DAISY WHEEIING <br> Own-a-Lisa <br> by <br> Arsen Darnay

The arms race, thank you, is doing just splendidly. And you, my friend, are about to discover (if you haven't felt it before) the dubious joys of 'falling behind ' . . . the other side. Unless, of course, you're willing to increase your defense budget by a couple of magnitudes.

By the time you read this, corporate Apple will have unveiled the mysterious Lisa computer.

Along with Lisa, the Macintosh (a Lisa scale-down) and the Apple IIE (a II+ scale-up) will be shown to the world, and the Apple II+ will be on the scrap heap of obsolescence.

I haven't seen any of these brave new contenders yet. Lisa is playing hard to get. According to the Wall Street Journal, dealers must apply for Lisa in writing and submit evidence to show that they can finance her acquisition. Mac and IIE may be visible sooner.

My purpose, thus, is not to speak of Power and of Speed, Graphics Galore and Oceans of Memory. I want to talk about the arms race in the world of Tron. Should I try to own a Lisa? Or budget failing, a Macintosh, an Apple IIE?

These questions really hide another one: What do you really do with your computer? Do you really need what the new hardware offers?

The answer for me is clearly No.
I came into Wonderland last summer. And while I haven't exactly slouched in the computer literacy department (on which more later), Apple II+ is still largely terra incognita for me.

It does everything $I$ want it to do. It's fast enough -- but I'm not in a hurry. I tend to scoff at 'user friendiness' -but then $I$ enjoy figuring things out on my own.

That feeling of excitement in the pit of my stomach when I read about new product in the world of Tron -- that's nothing more than greed, of course. If Moscow has a bigger missile, I want one too -whether I need it for defense or no!

I use my Apple a lot more than most. It's a tool in my busisness and works about 20 hours a week. It writes reports, keeps accounts, and does numerical analysis. I still do checks by hand. My own memory is good; I don't need Apple to remind me to take out the trash. And my furnace is smart enough to adjust its own temperature.

If I don't need to own a Lisa, why should the yearning masses of the rest of mankind?

Well, to be sure, Lisa is not meant for the home at all. It's positioned to compete with Xerox, CPT, and others for the small business market. But it makes you wonder, nevertheless.

We already have, out in the market, millions of Apples, Atari's, Commodores, TRS-80's, IMB's installed in homes. And more to come. We'11 have computing power orders of magnitude above any genuine requirements.

To use a computer effectively in the home, you have to be damned well organized and you have to love keying. Most people are not all that well organized at home -life's too short for pedantry. Menus, checkbooks and family budgets may go on the computer for a year -- but then they'11 go right back to the back of the envelope, the scratch pad, and the index card.

As for games -- you really won't need to own a Lisa to zap the aliens. And alien zapping will grow old no matter how great your graphics capability.

Which leaves education, the justification for buying the chip. The nation has begun to worship computer literacy -- which seems to me much easier and much harder to acquire than commonly held.

Easier in this sense: it's not that hard to learn how to run software packages.

To learn to program Tron is quite another matter. Literacy here means command of several languagest (Cobol, RPG-II, Fortran, etc.). And knowledge of CPU structures and assembly codes. And more: It's knowledge of the computer's fast-changing technological environment that really <br> \title{

Decimal or base 10 is useful because it is our "native" numbering system; we think in decimal. Binary or base 2 is useful because it is the computer's "native" numbering system; it "thinks" in binary. The transposing of decimal to and from binary, though, is awkward. We can work in binary, and when we are concerned with bit level operations, we should. But, when dealing with bytes of data or addresses (double bytes), binary becomes unwieldy. We often transpose ones and zeros and in general make mistakes in binary.

## Octal and hex to the rescue;

-binary easily translates to hex or octal
-octal and hex is more like decimal, and we are more comfortable with larger base numbering systems.

You might wonder why both octal and hex systems are used. Well, my guess is that octal was used because it is a subset of the decimal and that simplified operations on a computer and on reports to deal only with "numbers". Hex, on the other hand, uses alpha symbols (alphabetic letters) for the range above nine, which requires special handling - a disadvantage. But on the plus side, the partitioning or grouping of data favors hex because, as it works out, there are usually equal multiples of four. With full groups of bits, each number in each position can assume all of the values in its range. What happens when they are not equal? Well, a byte has eight bits, for conversion to octal, break it up into two groups of three with one group of two bits left over. The range of that last number position can only be from 0 to 3 (\%00 to $\% 11)$. When you forget that and try to make it four or larger, the computer can't accept it, and it takes you a moment to catch on as to why it won't. With hex in even multiples, all positions may assume their entire range. We11, regardless of the reasons for each system, the various users each chose a system and have argued which is better to this day.

To summarize, binary numbers can range from zero to one and each position has a power of two. Decimal numbers range from zero to nine, and each position has a power of ten. Octal numbers range from zero to seven and each position increases by a power of base eight. Each octal position represents three binary bits.

Thus the binary values from $\% 000$ to $\% 111$ are represented by the value 000 to 7 (\% identifies a binary number and ö identifies an octal number).
Hex numbers range from zero to fifteen, which poses a problem, as we have no symbols for numbers larger than nine. Being innovative and clever, though, the industry eventually decided to use the first five alpha characters as symbols for the five values above nine. Again each hex character represents four binary bits. Thus $\% 0000$ to $\% 1111$ can be represented by a value from $\$ 0$ to $\$ F$ ( $\$$ before or an $H$ after the number identifies a hex number). The following table shows the relationship between the various bases and the value of each position.

To transpose from binary to octal, break the binary number into three bit groups starting from the right with a partial group, if any, at the left. Examine each binary group and mentally add the three numbers to obtain the octal value. For example \%101; from the far right, two to the zero is 1 and there is a one thus $1 * 1$. The next is two to the one or 2 but there is a zero, so skip it. Finally two to the two is four and there is a one thus $4 * 1$, and $4 * 1+2 * 0+1 * 1=4+0+1=5$. This is the same way we translated small numbers from binary to decimal, if you recall. But in octal, larger numbers can be evaluated as easily. The number $\% 10011101$, which we determined was 157 in decimal last month can be translated to octal thus: take the first three bits from the right $101=4+0+1=5$, then the next three bits $011=0+2+1=3$, and the last two bits $10=2+0=2$, and finally reversing the order and putting them together, equals 235 ö (ö for octal).

To convert from binary to hex one must

While the Court refused to allow the patenting of software in Benson and Flook, it was careful to leave open the possibility that under the right circumstances, some types of computer programs might be patentable.

Such a case was decided in March 1981, in DIAMOND v. DIEHR ( 101 S.Ct. 1048). There the Court held that a process for molding cured precision rubber products by using a computer to monitor mold temperatures and constantly recalculate the exact curing time was patentable. The Court distinguished Benson and Flook on the grounds that the parties seeking the patent in Diehr did not seek to protect the algorithm but merely the use of it, with their process.

While the decision in Diehr confirms the patentability of computer programs in some limited contexts, it does not reduce the general uncertainty concerning the patentability of software. In the first place, the Supreme Court's analysis of an algorithm continues to equate them with mathematical formulae. An algorithm is really only a method for handling a particular task on a particular machine and may or may not include a mathematical formula. Thus, all computer programs are algorithms. By blurring this distinction the Court confuses the central issues and narrows the potential range of patentable programs ( 7 Ruttgers J.Comp.\& Law 333-35 1980).

Secondly, Diehr was, in fact, almost indistinguishable from Flook. The only real difference was one of drafting: the claim in Diehr was framed to place more emphasis on the curing process as a whole and Flook stressed the calculation in the conversion process. Joel M. Freed, during the Eighth Annual Judicial Conference (92 F.R.D.183), contends the Court of Customs and Patent Appeals... "seems to permit the patenting of most computer-implemented inventions so long as detail is paid to the claim language."

Because of these cases' factual similarities and their divergent results, the scope of patent protection for software remains unclear. To date, it appears, any effort to secure a patent on software as software is less likely to succeed than an effort to patent a narrowly defined process which incidentally uses the software.

only define one more bit, two to the third or eight. Using our example again, \%10011101 can be divided into two groups, as such, \%1001 1101. The first 1001 is 8 $+0+0+1$ or 9 , the next is $8+4+0+$ 1 or 13. Here is where the five alpha characters come in; after nine would come 10 or A , then 11 or B , and 12 or C , then 13 or $D, 14$ or $E$ and finally 15 or $F$. Thus 13 is represented by " $D$ " and the number is $\$ 9 \mathrm{D}$, or 9 DH (with the dollar sign or the H denoting hex base).

It is, I think you will agree, easier to remember \$9D, or even 2358 than \%10011101. This is even more apparent when the numbers are longer (CDC's CYBER ${ }^{\oplus}$ has 60 bits in each word) or one is examining long columns. It is also easier to examine columns of two hex numbers for an error than columns of ones and zeros.

Converting from hex or octal to binary is as simple, and after some experience one can convert both ways visually. A number like $\$ B 7$ is converted thus: $\$ B=8+3$ and 3 is $2+1$ thus $\$ B=8+2+1$ or $\% 1011$ and $\$ 7=4+3$ and 3 is $2+1$ and $\$ 7=4+$ $2+1$ or \%0111, and finally putting it together, \%10110111 is the number. To put it another way, if the hex number is equal to or larger than eight, subtract eight from it and put a one in the fourth position. Otherwise put a zero in the fourth position. Then examine the remainder, if there is a four in it subtract four, and put a one in the third position else a zero. Again examine the remainder, if there is a two in it subtract two, and put a one in the second position else a zero. Finally put a one or a zero in the first position as the remainder is a one or a zero. As I said last month the explaining of the method of converting from one base to another is more complicated than the method itself is.

The process of converting from decimal to either octal or hex is accomplished in the same way we converted from binary to decimal and vica versa. That is from octal or hexadecimal, find the value of each power and multiply that value with the number in that position. Finally add up the sub-totals. Boy, that sounds hard, even if it is simple. Let's do an example. Take the octal number 450. The value in the 5 position is eight to the zero or one, and in the 4 position is eight to the one or eight. To continue, $5 * 1+4 * 8=5+32=37$.

Now, if the number were $\$ 45$ the 5 position is 16 to the zero or one, and in the 4 position is 16 to the one or 16. Again continuing, $5 * 1+4 * 16=5+64=69$.

To go the other way, from decimal to octal or hex, divide the decimal number by the base number (8 or 16) you wish to convert to and keep track of the carries as we did with binary.

Personally, I like to convert to binary from decimal, and then visually convert to octal or hex; or from octal or hex to binary, then to decimal. There are fewer rules to observe and mistakes to make, I feel. In any case, you do what ever is comfortable, and a little practice makes perfect. I wish you good luck with your efforts.

# CUBAN FANTASY

Cuban Fantasy is a low-resolution graphic implementation in 3D of the popular puzzle known as Rubik's Cube". Through the use of two orthographic views of the cube displayed on the low-resolution graphics page, all six sides of the cube are visable at once. The six faces of the cube can be rotated with simple commands. A11 commands are easy to remember, and can be chained together (up to 100 moves). Also you can save a cube at any point on the disk and recall it back later to continue solving the puzzle.

Unfortunately, I never had much luck solving the original Rubik's Cube ${ }^{m}$ and after two months of frustration $I$ bought "the solution". I tried to use "the solution" book to solve the Cuban Fantasy. This is when all my problems with Cuban Fantasy became apparent. Commands were not included to rotate the entire cube so that the blue side could be positioned on top, as it was supposed to be to complete the solution. Since I now was completely disorientated, $I$ just aimlessly fumbled my way, rotating faces of the cube, without getting any closer to solving the mixed up cube. I really don't think that this was the fault of the software. It's probably just me, as the cube is the only puzzle $I$ have that $I$ haven't solved yet.

With it's low price I feel that Cuban Fantasy is a good bargain for any one who likes solving the Rubik's Cube ${ }^{\text {m }}$.
