

## mini'app'les Directors Meeting Minutes for December 3, 2007

In attendance: Don Walz, Bert Persson, Harry Lienke, John Pruski, Kevin Strysik, Chuck Hauge, Les Anderson, Erik Knopp Absent: Tom Gates

Agenda: Preliminary agenda adopted as submitted. See the Old Business and New Business items.

Minutes: The minutes for the October 1, 2007, meeting were approved electronically and published on the club BBS and on forumer.com on October 8.

#### **Directors Reports**

Treasurer Don Walz's report: All bills have been paid. Don distributed hard copies of the Balance Sheet; no discrepancies were noted.

SIG Director Kevin Strysik's report: OS X SIG location has just changed to 615 N Third St. No information is available on the Vectorworks meeting.

#### Old Business

Multi-SIG meeting site – Tom indicated March 15th looks like a good date to get the SIGs scheduled and publicized in multiple newsletters; Chuck will contact Tom to find out if this is a firm date. mini'app'les members should be on the lookout for other locations for multi-SIG meetings. Compensation for Buchner – No report from Tom; Bert will contact Greg and offer to pay out of pocket expenses.

IRS info – Don has received information from the IRS and will file Form 990. Tom is mailing another copy of his information to Ohio – this time with a receipt confirmation, et al. Once the IRS acknowledges our updates we can go back to St Paul and have the state update our info.

Budget, including membership dues change, if appropriate – Eric is getting ready to send out renewal notices and needed to know what dues should be requested in those notices. It was suggested we set the dues at \$10 per year; a second suggestion was made that we pro-rate existing memberships,

extending them according to the number of months remaining on the membership. It was pointed out that the expenses included in the minimal budget Harry proposed a few months back are not be covered by the \$10 fee. With 80 members the membership dues must be at least \$15 to get more than \$1000 in income. A motion was made to reduce dues to \$15 starting at the same time as we switch to an electronic newsletter; it was suggested that the process would be less complicated if the change was implemented January 1. The motion was changed to make the \$15 dues effective January 1, 2008, with existing memberships pro-rated; this motion was seconded and passed. Harry agreed to modify the budget he proposed several months ago to include the dues and electronic newsletter changes and to distribute it electronically so board members can review the financial situation expected in the future.

Yugma, Inc. check – Don has deposited the funds (\$90).

Group promotion and SIG descriptions – Kevin sent a request to SIG leaders for whom he had email addresses. The only response he received was a location change from Word; the BOD instructed him to use descriptions as sent since no-one objected to them. Harry and Les pointed out that SIG descriptions for the Appleworks and Q & A SIGs were provided some time ago.

Benefits list update – The changes have been made to the newsletter.

Adding email addresses to the Members-Helping-Members list – This has been done.

Move of club BBS to forumer.com – Chuck pointed out that since the mini'app'les forums were established on forumer.com, nearly twice as many people have posted on forumer as on the First Class BBS. Les expressed a concern relative to security on forumer; he believed people were accessing forums they should not be able to access. Chuck did a quick scan of people accessing the BOD area on forumer and reported that all people posting there were

authorized to access the area; he added that people must be authorized as guests before they can post messages and only members can access the Members Only area. The BOD forum can be accessed by a few exofficio board members in addition to the BOD members.

Single BBS or keep both First Class and forumer.com active – After some discussion exploring this issue, Harry made a motion to drop the First Class BBS on April 1 (when the change to the electronic newsletter is made); the motion was seconded and passed (Chuck, Kevin, Don, and Harry voting for the motion).

New flyer for advertising the club – John intends to provide a flyer - first items available in February.

Monthly email newsletter – Chuck will provide an example electronic newsletter with a minimum of formatting but including images.

Front page notice on the remaining hard copy newsletters to communicate the newsletter change and to ask all members to provide an email address – John will implement this on future newsletters.

Making new membership / renewal payments available via an online service, as well as including a snail-mail option – Chuck pointed out that we could collect dues through an on-line service for a charge of about 3%; the board felt we should stay with snailmail collection of dues and consider on-line dues collection after other changes have been smoothed out.

Audit of the books – Don brought the info to the BOD meeting. John will try to deliver it to Bruce.

Insurance bill from the Hartford – Don talked to Hartford indicating we chose not to renew our policy with them and there has not been any additional communication.

#### New Business

Renewal of domain name – This renewal is not due until October, 2008. A recommendation to wait and see was adopted. Chuck agreed to

investigate this item, including our host service.

Scheduling of Annual Meeting – Bert scheduled the Southdale Library on February 16, 10:00 am.

Conducting the Board election (how do we distribute ballots with an electronic newsletter?) – Tom's suggestion to do balloting via a separate mailing with a one-piece reversible document was adopted. John will produce the form.

Next meeting: Scheduled for February 4, 2008, at the Merriam Park Library at 7:00 pm. All club members are welcome to attend.

## Mac Office 2008 ready for Macworld Expo launch

Microsoft's Macintosh Business Unit (MacBU) has signed off on the latest build of Office 2008 for Mac and has released the software to manufacturing. That means the suite is done.

"While we love building Mac software, actually getting that software into the hands of the people we've been building it for is something we've been looking forward to for a long time," said Geoff Price, Product Unit Manager at the MacBU in a blog posting.

The long-awaited Intel-native Office, featuring programs such as Word, Excel, Powerpoint, and Entourage, was originally scheduled to be released in the second half of 2007, but was delayed in August until the

new year.

Craig Eisler, general manager of the Macintosh Business Unit, explained at the time that the delay was the result of a combination of a "perfect storm" of factors that hampered the development effort.

"We switched to Intel, and Office changed file formats," said Eisler. "It was no one thing. This release was harder than most just because of all those things happening at once."

Office will be available in three versions: Office 2008 for Mac (\$399.95; \$239.95 upgrade), Office 2008 for Mac Home and Student Edition (\$149.95) and Office 2008 for Mac Special Media Edition (\$499.95; \$299.95 upgrade).

And Microsoft is not known for releasing upgrades that actually perform faster than their predecessors. Even if it is faster, most of my time using office apps is spent in Word. And most of that time is spent writing scholarly articles. So I've got to worry about my 700+ references in EndNote. The EndNote developers tend to be a bit slow to update for new versions of Word. I'm therefore unlikely to upgrade for awhile, despite it being nearly free through my university affiliation. For all that, though, I'll eventually upgrade I'm sure. I have to be able to collaborate with PC users, and telling them to save their Word files in the old format is getting... well, old. Especially because the Office 2007 (PC) interface is so radically different that they can't find the Save As command.:)

I use tables, figures, graphics, footnotes, headers, footers, sections, tables of contents, etc. OpenOffice just isn't up to the task. Some days, Word 2004 isn't either. And, even if I did find one that was 100% compatible, EndNote's cite while you write feature only works with Word. I've tried Word and EndNote alternatives, but none of them work as well. That's saying a lot, because I'm not terribly happy with Word/EndNote. For casual documents, however, OpenOffice is a great alternative. For most users, it works well. Now, if they could just get the Mac native version working, since NeoOffice is painfully slow...


